| <p>Social and Environmental Entrepreneurs and a partnership of five philanthropic organizations were selected to serve as the Region 9 Grantmaker for the EPA Environmental Justice Thriving Communities Grantmaking Program (EJTCG). EJTCG is a new, Inflation Reduction Act-funded \$600 million program that will work with Grantmakers from across the country to deliver environmental justice small grants to community-based organizations and other eligible subrecipients over the next three years.</p> <p>The Region 9 partnership will distribute \$40 million over three years to support environmental justice projects throughout EPA Region 9, which covers Arizona, California, Hawaii, Nevada, American Samoa, the Commonwealth of the Northern Mariana Islands, Guam, and 148 Tribal Nations. The partners will collaboratively design and implement the subgrants program, leveraging each partner’s existing grantmaking expertise and connections in local communities.</p> <p>Resources Legacy Fund (RLF) will lead outreach and the grantee selection process in Central and Northern California, Hawaii, American Samoa, the Commonwealth of the Northern Mariana Islands, Guam and will work in collaboration with the other partners to design and manage the program.</p> | |

RLF is seeking a consultant to support outreach and grantmaking in the Commonwealth of the Northern Mariana Islands and Guam over a three-year term.

Scope of Work

1. In collaboration with RLF and the other R9 partners, design and implement a robust communication and outreach strategy to ensure the program authentically reaches disadvantaged communities in the Commonwealth of the Northern Mariana Islands and Guam.

Specifically, the consultant will:

- Develop multilingual and culturally appropriate communications and outreach materials, such as mailers, emails, infographics, social media content, and FAQs to disseminate program information to all constituencies impacted by environmental justice issues, especially low-income, immigrant, non-English speaking, and Indigenous communities in the Commonwealth of the Northern Mariana Islands and Guam.
- Conduct several multilingual, culturally appropriate in-person and virtual informational sessions to share program information with prospective applicants.
- Staff a program telephone line to respond to applicant questions, provide application support, and provide an alternative application pathway for digitally isolated communities.
- Field eligibility questions from applicants in the Freely Associated States, which are ineligible for this program.

2. In collaboration with RLF, support the grant selection process in the Commonwealth of the Northern Mariana Islands and Guam.

Specifically, the consultant will:

- Respond to applicant inquiries

- Identify and connect applicants and eligible communities to related technical assistance resources available through the program, such as the Thriving Communities Technical Assistance Centers, to support development and implementation of proposals.
 - Respond to inquiries from and provide information to the Region 9 selection committee regarding proposals received from Commonwealth of the Northern Mariana Islands and Guam.
3. Attend regular meetings with RLF, R9 partners, R9 Community Advisory Panel, Thriving Communities Technical Assistance Centers, and EPA, as requested.
 4. Provide reports, timecards, and program performance information as required by the EPA, Social and Environmental Entrepreneurs, and RLF.

Qualifications

- Be based in either the Commonwealth of the Northern Mariana Islands or Guam.
- Demonstrate strong connections to and relationships with a broad range of community-based organizations in the Commonwealth of the Northern Mariana Islands and Guam.
- Have experience with federal grantmaking programs, including proposals, compliance, and reporting.
